Proposed 2020 Budget Agenda – WEEK 1

As per the Public Notice By-law, Chatham-Kent Council hereby gives public notice of its intention to hold public meetings, and adopt the 2020 Budget immediately following receipt of a recommended budget from the Chatham-Kent Budget Committee.

The Budget Committee also gives public notice of the need to meet in Closed Session at any time during the budget deliberation process, as permitted by the Municipal Act, 2001.

The Budget Committee will be deliberating the 2020 budget over the next few weeks. Three evening meetings, January 28, 29 and 30, open to the public, have been set aside from 6:00 to 10:00 pm in the Council Chambers at the Civic Centre located at 315 King St. West in Chatham, Ontario. February 4 and 5 have been set aside if additional time is needed.
