## A GUIDE TO BUSINESS LICENCES IN THE MUNICIPALITY OF CHATHAM-KENT

### WHAT TYPES OF BUSINESSES REQUIRE A LICENCE?

### WHY DO CERTAIN BUSINESSES NEED TO BE LICENCED?

The main goal of a municipal business licence is to protect the health and safety of the public who use the service. It also helps ensure the consistency for business owners and customers. The Municipality's Consolidated Business Licensing By-law and amendments provide the rules and regulations for each licenced business. ### ZONING

### WHAT DO I NEED TO APPLY FOR A BUSINESS LICENCE

Every application for a Municipal Business Licence requires the following information:

#### Articles of Incorporation or Master Business Licence

Provide a copy of your provincial master business licence or articles of incorporation, if applicable, in order to apply for a municipal business licence. Visit [www.ontario.ca/page/business-services](http://www.ontario.ca/page/business-services) to register your business name and obtain your master business licence.

#### Application Form and Licence Fee

Municipal Business Licence application forms are available [here](#). The fees for application and renewal vary depending on the licence category. For more information on the different application types, fees, and documentation required please view Schedule A online or call the Municipality of Chatham-Kent Licensing department at 519-360-1998.

#### Some business licence applications may require the following to accompany the application:

##### Police Records Check

Chatham-Kent Police Service will provide a criminal record check for local residents. For more information visit [www.policeresolutions.ca/checks/services/chathamkent](http://www.policeresolutions.ca/checks/services/chathamkent). For licensees that reside outside of Chatham-Kent the police record check must be obtained from the Municipality where the resident permanently resides. Police record checks are required for door to door sales, old gold or other precious metals, vehicle for hire, pawn shop, and second hand shop licences.

##### Floor Plans & Site Plans

A detailed drawing of the interior of the building, unit, or space your business will operate including washroom(s), kitchen, entrance and exit doors, windows, seating, etc. Everything that will help

staff understand how the space is going to be used.

- Bunk House, Rental Dwelling Unit, Large, and Bed & Breakfast Establishments will require a floor plan as well as a list detailing the number of rooms, number of beds in each room, and number of persons per bedroom
- Food Cart/ Mobile Food Cart, and Ice Cream Cart (Motorized and Non-Motorized) require a written letter of permission provided by the owner of the property where the cart will be operated as well as a site plan depicting the exact location of the cart on the property. A Vending Zone Permit will be required if operating on municipal property

#### Insurance and Deposits

Mobile Food Carts, Ice Cream Cart Sales – Motorized, and Ice Cream Vehicles require automobile insurance in an amount not less than 1 million per occurrence. Pawn Shops require security in the form of a letter of credit or cash security deposit in the amount of \$2000.00 (must be valid for duration of licence).

#### Technical Standards and Safety Authority (TSSA)

All food carts and mobile food carts shall obtain a TSSA Mobile Food Service Equipment Annual Inspection, as required by law, and maintain an up-to-date certificate of that inspection in the Food Cart or Mobile Food Cart at all times during operation.

#### Other Application Requirements

- Mobile Food Carts, Ice Cream Cart Sales – Motorized, and Ice Cream Vehicles require the VIN number and the Ontario license plate number as issued by the Ministry of Transportation for each licensed vehicle

## WHAT OTHER THINGS DO I NEED TO KNOW BEFORE SUBMITTING A BUSINESS LICENCE APPLICATION?

### Check the Building Requirements

Before you sign the lease or purchase a property it is important that the building complies with the Ontario Building Code. If renovations are required, you may require a building permit. Depending on the previous use of the building, you may require a change of use permit. ### Operating on Municipal Property?

Businesses operating on municipal property will be required to complete a Vending Zone Permit Application and receive Municipal approval before doing so. Upon receiving approval a licence fee and insurance documentation (liability insurance naming the Municipality of Chatham-Kent as additionally insured) must be provided in order for a Vending Zone Permit to be issued. ## WHAT HAPPENS AFTER I SUBMIT MY LICENCE APPLICATION?

Once you submit your application, the necessary inspections will be arranged for you including Building, Fire, Health, and Police – where applicable. You will be informed when you apply the inspections that are required. If you need to contact individual inspectors or departments, call:

## WHAT IS BEING INSPECTED?

Different departments inspect different aspects of your business. Municipality of Chatham-Kent staff, or the individual organizations, may be able to provide you with a general list of what to expect before your inspections.

## WHAT IF I DON'T PASS MY INSPECTIONS?

If deficiencies are found during the inspection, inspectors will provide you a written list of them. It is up to you to correct the issues and book the inspection(s) again. Do not apply for or book inspections if you are not ready for them. Individual departments or divisions may charge for re-inspection. If you do not pass your inspections, or have questions about something on the list, talk to the inspector directly. They will help you understand how to fix the problem. A Municipal Business Licence will not be issued until all inspections are approved by the required departments.

## HOW LONG ARE LICENCES VALID FOR?

Municipal Business Licences are valid for one year, from date of issuance. There are exceptions to this; Food Cart, Mobile Food Carts, Ice Cream Carts, Motorized and Non-Motorized, and Vehicle for Hire licences renew every year in May. Bunk House licences have an annual renewal of September. Business Licence fees are not prorated and are issued based on application and inspection approvals – if applicable. The Municipality of Chatham-Kent will send renewal reminders by mail – as a courtesy – approximately 45 days prior to licence expiry. It is the licence holder's responsibility to ensure that the licence is valid and up-to-date whether you receive the reminder or not.
