Subject: 2020 Splash Pad Lifecycle Projects

## **Recommendation**

It is recommended that:

1. The 2020 splash pad lifecycle projects valued at an estimated cost of \$40,120 to be funded through the Splash Pad Lifeamp Reserve, be approved.

## <u>Background</u>

The Municipality maintains 8 splash pads in the Communities of Bothwell, Chatham, Mitchell's Bay, Ridgetown, Tilbury, Thamesville, Wallaceburg and Wheatley.

The Splash Pad Lifeamp Reserve was established with funding from the following areas:

- One-time allotment of utility funds for the Tilbury splash pad not utilized in 2011 in the amount \$15,000
- An annual splash pad lifeamp allotment implemented in 2015 in the amount of \$8,500 and increased to \$28,500 in 2017
- In 2016, a transfer of pool reserves remaining after the closure of Memorial Pool in Chatham in the amount \$55,800
- An allotment of \$8,500 was approved during 2018 budget deliberations for the lifeamp funding of the new Wallaceburg splash pad

This reserve will be used to fund repair and replacement costs of various splash pad components.

#### **Comments**

Administration has identified the following priority project to be completed in 2020:

Location	Project	Comment
Tilbury Splash Pad	Drain repair	Surface around the drain is heaving causing a trip hazard
Kingston Park Splash Pad	Drain repair	Repair broken subsurface drain pipe

A contingency has been included in the total cost for quote overages and emergency repairs or replacements.
