## **Recommendations**

It is recommended that:

- 1. The Erieau Road & Bisnett Line Waterline Project and the necessary By-law under Part XII of the Municipal Act, 2001 be approved.
- Administration be authorized to borrow monies towards the project by the issuance and sale of debentures. Pending the sale of the debentures, the Mayor and Treasurer are authorized to make such temporary borrowing as may be required in order to meet the payments due to vendors.

### Background

Due to ongoing issues with Erie Shore Drive, the Chatham-Kent Public Utilities Commission (CK PUC) for the Municipality of Chatham-Kent has decided to install a secondary water supply for the community of Erieau. The new 300 mm diameter watermain will run along Erieau Road from Old Street Line to Erie Shore Drive and will also connect and loop along Bisnett Line. This will reinforce the watermain grid system in the south Chatham-Kent region.

Dillon Consulting Ltd. performed extensive hydraulic modelling and determined that CK PUC is able to supply adequate water capacity for the community of Erieau with the addition of a new watermain on Erieau Road, which would include a watermain along Bisnett Line.

The costs of this proposed project will be shared between CK PUC and any properties that receive a connection within the project boundaries. The residential properties along Erieau Road would be given the option to connect or not.

#### Comments

The water distribution system network for this area will include the installation of a 300mm diameter main on Erieau Road that will connect to the existing water line at the intersection of Old Street Line and Erieau Road. It will continue south along Erieau Road to Erie Shore Drive. As well, a new 150mm diameter main will be installed on Bisnett Line from Gore Road to Erieau Road to provide looping for this watermain. The watermains will total approximately 7,900 metres.

The forty-one (41) properties along Erieau Road were given the opportunity to buy into the project to acquire a water service. A total of twenty-seven (27) properties are considered a 100% assessment with an estimated cost of \$27,767 which includes the 2020 Part XII Charges of the Municipal Act, 2001. There are two (2) properties that would be considered a 125% assessment with an estimated assessment of \$33,989 including the 2020 Part XII Charges. An additional service connection charge of 25% is applied to these properties that have an additional dwelling but do not receive a second connection. Eight (8) property owners signed "YES" on the Connection Request Form. One (1) of the properties has an additional residential dwelling and requested two (2) service connections. This property is considered a 200% assessment.

Out of the remaining thirty-three (33) properties, six (6) property owners signed "NO" to a water service connection and twenty-seven (27) of the property owners did not return their Connection Forms. The property owners that signed "NO" or did not return their forms will be deferred at an estimated connection cost of \$31,109 not including Part XII Charges. CK PUC would pay for and carry the deferred assessments until the property owners wish to connect.

Currently, there is a 50mm private water line along Bisnett road that extends north from Gore Road approximately 1030 metres. This water line will be replaced with a 150mm municipal water line that extends to Erieau Road. The residents that currently have a connection on this private line will receive a connection on the new municipal line with no assessment fee.

Chatham-Kent Engineering and Transportation and Dillon Consulting Ltd tendered the project according to the Chatham-Kent Municipal tendering procedure. The tendered cost for the project is \$2,159,000 of which \$833,723 was estimated by Dillon Consulting Ltd for the costs to construct the minimum size watermain (100mm diameter) for the properties on Erieau Road to receive a connection. The eight (8) properties that have signed to receive a connection will account for \$249,905 (including Part XII Charge) of the project costs. The remaining cost of \$1,909,095 associated with the carrying costs for the deferred residential properties, the watermain to loop on Bisnett Road, and the oversizing required would be allocated to CK PUC.

It is recommended that Council approve the Erieau Road & Bisnett Line Watermain Project By-law as outlined in Schedule "A" and Schedule "B" and the necessary By-law under Part XII of the Municipal Act, 2001.

#### **BY-LAW NUMBER**

## OF THE CORPORATION OF THE MUNICIPALITY OF CHATHAM-KENT

A By-Law to authorize the construction of a water works and the imposition of a water rate for the payment of the capital cost of the construction of such water works; (Erieau Road & Bisnett Line Waterline Project)

FINALLY PASSED the day of , 2021.

**WHEREAS** the Council of the Corporation of the Municipality of Chatham-Kent authorized the Public Utilities Commission for the Municipality of Chatham-Kent to prepare the plans and specifications for the proposed Water Works.

**AND WHEREAS** the need for a secondary water supply for the community of Erieau was determined due to ongoing issues on Erie Shore Drive.

**NOW THEREFORE** the Municipal Council of The Corporation of the Municipality of Chatham-Kent enacts as follows:

### **SHORT TITLE**

1. This By-law may be cited as the "Erieau Road & Bisnett Line Waterline Project" Water Works By-law.

## **DEFINITIONS**

- 2. In this By-law,
- (i) "Corporation" means the Corporation of the Municipality of Chatham-Kent;
- (ii) "Council" means the Council of the Corporation of the Municipality of Chatham-Kent;
- (iii) "Municipal Act" means the Municipal Act, 2001, as amended from time to time:
- (iv) "Public Utilities Commission" means the Public Utilities Commission for the Municipality of Chatham-Kent;
- (v) "Service Connection" means the pipe and appurtenances that connects the waterline to the street line;
- (vi) "Street line" means the boundary of a property adjoining a road allowance;
- (vii) "Water Works" means any works for the collection, production, treatment, storage, supply or distribution of water, or any part of such works;
- (viii) "Water Works Rate" means a charge for the capital cost of water works.

(ix) "Water line" means the distribution pipe which carries the supply of water along the road allowance.

### APPLICATION OF BY-LAW

- 3. The Water Works referred to herein shall be constructed pursuant to the provisions of the *Municipal Act, 2001*, and shall impose fees and charges under Part XII of that Act.
- 4. The Water Works, including waterlines and appurtenances, shall be constructed along the lands shown on Schedule "A" attached hereto.
- 5. The Public Utilities Commission is hereby authorized to make such plans, profiles, and specifications and furnish such information as may be necessary for the making of a contract or contracts for the execution of the Water Works.
- 6. The Public Utilities Commission is hereby authorized to cause a contract or contracts for the construction of the said Water Works to be made and entered into, including the administration of a tender process, and to execute any related documentation to give effect thereto.
- 7. The construction of the Water Works shall be carried out and executed under the direction of the General Manager of Water and Wastewater Services for the Public Utilities Commission.
- 8. The Treasurer for the Corporation may make such arrangements with the Canadian Imperial Bank of Commerce, a chartered bank in Canada, for the temporary advances of monies to meet the cost of the Water Works pending the completion of the same.
- 9. The Water Works may be financed over a period not more than fifteen (15) years at a rate of interest to be determined by the Treasurer for the Corporation. The Water Works shall be paid for by the imposition of a water works rate on the benefiting lands computed by a unit charge for each parcel or parcels of lands, which is a parcel separately assessed according to the last returned assessment roll, or parcels having received severance consent by the date of this By-law, in accordance with the Schedule of Assessment attached hereto as Schedule "B".

- 10. Only one Service Connection will be permitted for each separate parcel or parcel having received severance consent by the date of the enactment of this By-law, assessed in Schedule "B", unless specifically provided otherwise in Schedule "B".
- 11. Council hereby authorizes the borrowing of monies for completion of the Water Works by the issuance and sale of debentures. Pending the sale of the debentures, Council hereby authorizes the Mayor and Treasurer to undertake such temporary borrowing as may be required in order to pay any amounts that become due and payable as a result of proceeding with the Water Works project.

### **FUTURE CONNECTIONS**

- 12. If a severance occurs on a parcel assessed in Schedule "B," after the date of the enactment of this By-law, the owner(s) of the severed parcel will be required to pay to the Corporation the cost of one unit as set out in Schedule "B."
- The owner of an existing parcel will be required to pay to the
   Corporation, the cost of any additional connections to the parcel.

## **VALIDITY**


14. If a court of competent jurisdiction declares any provision or part of this By-law to be invalid or of no force and effect, it is the intention of the Council in enacting this By-law that each and every other provision of this By-law authorized by law, be applied and enforced in accordance with its terms to the extent possible according to law.
