

Notice of Complete Application and Public Meeting to Consider an Application for Consent and Zoning By-law Amendment

Take Notice that the Municipality of Chatham-Kent has received a complete Combined application (**File D-28 ZO/12/25/W**) for Consent (**File B-20/25**) and Zoning By-law Amendment (**File D-14 ZO/17/25/W**) under Sections 53 and 34 of the Planning Act, R.S.O.1990, c.P.13, as amended, concerning property located at 30079 Peter Road, in Part of Lots 12-17, North of Peter Street, Registered Plan 142, and Part of Lot 5, North of Longwoods Road, Community of Zone (East Kent)

And Take Further Notice that an application under the above file numbers will be heard by Municipal Council on the date and at the time shown below:

Purpose and Effect: The subject property is located on the northeast side of Peter Road, with additional frontage on Longwoods Road, in the Community of Zone (Roll No. 3650 310 003 21800). The lands are approximately 29.8 ha (77.64 ac.) in area and contain a single detached dwelling. The lands are designated Suburban Residential Area and Open Space and Conservation Lands in the Chatham-Kent Official Plan and zoned Open Space-383 (OS1-383).

The application proposes to sever a new residential parcel, approximately 1.1 ha (2.73 ac.) in area, consisting of the vacant lands along the Peter Road frontage adjacent to the existing residential lots. The land has historically been used to grow hay. The retained parcel will be approximately 28.7 ha (74.91) in area and contain the existing dwelling and woodlot.

Zoning By-law Amendment

To implement the proposed severance, a zoning by-law amendment application is required to rezone the severed lot to a site-specific Rural Residential-1753 (RR-1753) Zone to facilitate residential development and implement an appropriate development setback (30 m) from the existing natural heritage feature (woodlot).

Any person may make written representation in support of or in opposition to the proposal.

Any Person may attend the public meeting and/or make written representation in support of or in opposition to the proposed zoning by-law amendment or consent application. Those who wish to address Council respecting this matter are requested to notify the Municipal Clerk's Office by telephone prior to the meeting.

If You Wish to be notified of the adoption of the proposed zoning by-law amendment or proposed consent, you must make a written request to the **Municipal Clerk, Municipality of Chatham-Kent, at the address below.**

If a Specified Person or Public Body would otherwise have an ability to appeal the decision of Council of the Municipality of Chatham-Kent to the Ontario Land Tribunal but the person or public body does not make oral submissions at the public meeting or make a written submission to the Corporation of the Municipality of Chatham-Kent before the by-law is passed or consent is granted, the person or public body is not entitled to appeal the decision.

If a Specified Person or Public Body does not make oral submissions at the public meeting or make a written submission to the Municipal Clerk of the Corporation of the Municipality of Chatham-Kent, before the by-law is passed or consent granted, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.
