#### **Notice of Decision**

It is hereby certified that the Council of the Municipality of Chatham-Kent at its meeting on November 17, 2025:

#### **Approved**

- 1. Consent application File B-72/25, concerning the property known as 7170 John Park Line, in Part of Lot 14, Concession 1, in the Community of Chatham Township, to sever and convey 826 sq. m (8,892 sq. ft.) of land, shown as Part 1 on the applicant's sketch, as a lot addition, subject to the following conditions:
  - a) that the Chatham-Kent Zoning By-law be amended to:
    - i) rezone the lot addition lands to a site-specific Agricultural-1 (A1-1) zone to match the zoning of the receiving parcel; and,
    - ii) rezone the retained parcel to a site-specific Agricultural-1763 (A1-1763) zone to recognize the resulting lot area being 1.3 ha (3.2 ac.);
  - b) the lot addition lands to be severed, shown as Part 1 on the applicant's sketch, be conveyed to the owner of the abutting parcel (7161 Base Line / PIN: 00589-0540) and Section 50(3 or 5) of the Planning Act applies to any subsequent conveyance of or transaction involving the parcel of land that is subject of this consent;
  - c) that a legible hard copy of the final reference plan be submitted to the Municipality, and;
  - d) that the necessary deed(s), transfer or charges be submitted in triplicate; signed and fully executed (no photo copies). It will be necessary to allow up to three (3) working days after all conditions have been fulfilled and documentation filed for the issuance of the Certificate (stamping of deeds).

**Council passed By-law No. 137-2025,** to rezone the lands in accordance with the conditions noted above.

# **Reasons for Approval**

The reasons for the Decision are incorporated in the Planning Services report dated November 17, 2025 which was adopted by Council. There were no written or oral submissions received with respect to the application prior to the decision of Council.

The last day for appeal of this Decision is **December 8, 2025.** 

All conditions relating to the consent <u>must</u> be completed within two years of the date of this Notice of Decision.

## **Notice of Right to Appeal**

An appeal to the Ontario Land Tribunal (OLT) in respect of this matter, setting out the objection to the decision and the reasons in support of the objection, must be filed with the Municipal Clerk of the Municipality of Chatham-Kent via the OLT's e-file service at <a href="https://olt.gov.on.ca/e-file-service/">https://olt.gov.on.ca/e-file-service/</a> by selecting Chatham-Kent as the Approval Authority. Please note, first-time users of the OLT's e-file service will need to register for a My Ontario Account. If the OLT's e-file service is not working, please file the appeal with the Municipal Clerk at ckclerk@chatham-kent.ca (or at 315 King Street West, Box 640, Chatham, Ontario, N7M 5K8), no later than 4:30 p.m. on or before the last date of appeal, noted below. Should this date fall on a holiday or weekend, you will have until 4:30 p.m. of the next business day to file your appeal. The appeal fee of \$400 can be paid online through OLT's e-file service or by certified cheque/money order to the Minister of Finance, Province of Ontario. Only the applicant, the Minister, a specified person or any public body may appeal decisions in respect of application for consent to the Ontario Land Tribunal.

You will be entitled to receive notice of any changes to the conditions of the provisional consent if you have either made a written request to be notified of the decision to give or refuse to give provisional consent or make a written request to be notified of changes to the conditions of the provisional consent.

# **Notice of Planning Act Approval**

Take Notice, that on **November 17, 2025**, Council of the Corporation of the Municipality of Chatham-Kent approved Consent Application (**Files B-72/25**) & Zoning By-law Amendment (**File D-14 CH/40/25/K**) submitted for property located at 7170 John Park Line, Part of Lot 14, Concession 1, in the Community of Chatham (Township) (North Kent) (Roll No. 3650 410 008 13900).

At the meeting, Council approved Consent Application File B-72/25 to sever and convey 826 sq. m (8,892 sq. ft.) portion of land as a lot addition to the abutting parcel at 7161 Base Line.

**Zoning By-law No. 137-2025** was passed by Council to rezone the lot addition lands to match the current zoning of the receiving parcel, being A1-1, and rezone the retained parcel to A1-1763 to recognize the resulting reduction in lot area.

#### **Reasons for Approval**

The reasons for the Decision are incorporated in the Planning Services report dated November 17, 2025 which was adopted by Council. There were no written or oral submissions received with respect to the applications prior to the decision of Council.

### When and How to File an Appeal

An appeal to the Ontario Land Tribunal (OLT) in respect to all or part of this Zoning By-law Amendment can be made by filing a notice of appeal with the Municipal Clerk via the OLT's efile service at <a href="https://olt.gov.on.ca/e-file-service/">https://olt.gov.on.ca/e-file-service/</a> by selecting Chatham-Kent as the Approval Authority. Please note, first-time users of the OLT's e-file service will need to register for a My Ontario Account. If the OLT's e-file service is not working, please file the appeal with the Municipal Clerk at ckclerk@chatham-kent.ca (or at 315 King Street West, Box 640, Chatham, Ontario, N7M 5K8), no later than 4:30 p.m. on or before the last date of appeal, as noted below. Should this date fall on a holiday or weekend, you will have until 4:30 p.m. of the next business day to file your appeal. The appeal fee of \$1,100 can be paid online through OLT's e-file service or by certified cheque/money order to the Minister of Finance, Province of Ontario. If you wish to request a fee reduction for an appeal, forms are available from the OLT website at <a href="https://www.olt.gov.on.ca">www.olt.gov.on.ca</a>.

# Last Date of Appeal: December 8, 2025

#### Who Can File an Appeal

Only the applicant, the Minister, a specified person or any public body may appeal a by-law of the Municipality to the Ontario Land Tribunal. A notice of appeal may not be filed by an unincorporated association or group. However, a notice of appeal may be filed in the name of an individual who is a member of the association or the group on its behalf.

No specified person or public body shall be added as a party to the hearing of the appeal unless, before the by-law is passed, the specified person or public body made oral submissions at a public meeting or written submission to the Council of the Municipality of Chatham-Kent or, in the opinion of the Tribunal, there are reasonable grounds to add the specified person or public body as a party.

### When the Decision is Final

The decision of the Municipality of Chatham-Kent is final if a Notice of Appeal is not received on or before the last date of appeal noted above.
