

Notice of Planning Act Approval

Take notice, that on **November 28, 2022**, Council of the Corporation of the Municipality of Chatham-Kent approved Zoning By-law Amendment application (File D-14 RA/35/22/C), submitted by Chatham-Kent Recycling Inc. for property located at 6584 Middle Line, Community of Raleigh (South Kent) (Roll No. 3650 110 007 09500).

Zoning By-law No. 205-2022 was passed by Council to rezone portions of the lands from Village Residential (VR) and Agricultural (A1) to Salvage Yard Industrial-1630 (M3-1630) and Open Space-1631(OS1-1631), to permit an expansion to an existing industrial use and to limit the uses of certain lands to open space type uses and existing agriculture.

Reasons for Approval

The recommendation of Administration was to approve the application for the reasons outlined in the Planning Services Report, dated September 29, 2022. There were five (5) written submissions received by the Municipal Clerk in advance of the public meeting. The following is a summary of the submissions received:

- Emissions (dust, noise)
- Drainage
- Impact to property value
- Traffic
- Further consultation required

The submissions were received, and have been, on balance, taken into consideration by Council as part of its deliberations and final decision on this matter. In the opinion of Council, the approval is consistent with the Provincial Policy Statement and conforms to the Chatham-Kent Official Plan.

When and How to File an Appeal

Your appeal, together with the reasons for the appeal and the \$1,100.00 fee as required by the Tribunal, are to be made payable to the Minister of Finance in the form of a certified cheque or money order. An A1 Appeal Form provided by the Tribunal is on its website at <https://olt.gov.on.ca/appeals-process/forms/> and must be filed with the Municipal Clerk at 315 King Street West, Box 640, Chatham, Ontario, N7M 5K8, no later than 4:30 p.m. on or before the last date of appeal, noted below. Should this date fall on a holiday or weekend, you will have until 4:30 p.m. of the next business day to file your appeal.

Last Date of Appeal: December 20, 2022.

Who Can File an Appeal

Only individuals, corporations and public bodies may appeal a by-law of the Municipality to the Ontario Land Tribunal. A notice of appeal may not be filed by an unincorporated association or group. However, a notice of appeal may be filed in the name of an individual who is a member of the association or the group on its behalf.

No person or public body shall be added as a party to the hearing of the appeal unless, before the by-law is passed, the person or public body made oral submissions at a public meeting or written submission to the Council of the Municipality of Chatham-Kent or, in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party.

When the Decision is Final

The decision of the Municipality of Chatham-Kent is final if a Notice of Appeal is not received on or before the last date of appeal noted above.
