Subject:	Municipal Digital Transformation Grant Program Update	

This report is for the information of Council.

Background

At the December 7, 2020 Council meeting, Council approved \$125,000 to be utilized from the monies received from the Province's Safe ReStart program to provide Chatham-Kent's small businesses the opportunity to apply for funding to develop or enhance their online presence during their economic recovery from the COVID-19 pandemic.

Because of the restraints in the highly successful provincially funded Digital Main Street program of which eligible businesses needing to be being located in downtown areas, hundreds of rural Chatham-Kent businesses were deemed ineligible for grant funding to improve their digital footprint. This dilemma was highlighted in the CK COVID Economic Recovery Municipal Response report that Council received on September 28, 2020 with the recommendations that, "if COVID-19 funding criteria allows, Council encourage allocating up to \$250,000 to offer Digital Main Street supports to businesses outside of the 1 km. designated radius of the existing grant. These additional dollars will allow the businesses to receive support in re-building through an e-commerce model."

Comments

An online application process for this program was issued on December 11, 2020 with a closing date of January 4, 2021. Economic Development Services' received 110 inquiries during this time period with 50 of these small businesses completing grant applications and providing supporting documentation (Attachment A). All successful applications were processed by February 13, 2021 with payments being deposited within 30 days.

This grant funding can be utilized to improve websites, search engine optimization, digital marketing, creation of video and photography galleries, increase online marketing efforts, upgrade technology or purchase e-commerce solutions. These funds were not intended to cover existing operating costs such as rent and utilities or compensating for lost revenues during the pandemic.

Eligibility for Municipal Digital Transformation Grant Funding

- Must be an existing small business outside of a BIA downtown district located in Chatham-Kent
- Must be a full-time business venture (35+ hours per week)
- Is a sole proprietorship, partnership or a corporation where the applicant is a majority shareholder (if incorporated, application and grant funding is in personal name)
- Is an independent business venture
- If applicant owns multiple businesses, only one of the businesses may apply and be eligible for the grant
- Fits the Canada Revenue Agency's definition of being self-employed FORM RC <u>4110 through the website.</u>

Businesses not eligible:

- Franchises, commissioned sales and distributorships
- Not-for-profit or charitable enterprises or publicly funded organizations
- Multi-level marketing ventures
- Previous recipients of a Digital Main Street grant or the Municipal Digital Improvement Grant
- Single events such as musical ventures, bands, DJs or dance/party event organizations

It is common knowledge that many small businesses have been hit hard by the pandemic. Wallaceburg Bookbinding (WBM) being one of them. Our sales have decreased by 75% since the pandemic hit. There is nothing we can do to get our traditional work back as long as our traditional customers are still closed. Libraries in general including academic libraries and schools have all been forced to change the resources they use for learning. This in turn has formed WBM to look in new directions as the pre-pandemic workflow is no longer status quo.

We know that "ONLINE" and "E-Commerce" is now key to survival. Our current product offerings must change, and we need to expand our customer target from institutional to include consumers. We have been at the drawing board extensively and believe we have finally come up with a product that consumers will want.

The timing of the digital transformation grant was perfect. We applied and received \$2,500 which will be used to start upgrading our website to include e-commerce (which will also be work for a local marketing company). We have much to do now to launch our new product idea. I wish it was fully launched at the time of this writing, but will likely be about 8-12 weeks yet as we work out all of the logistics to make this happen. When we go live with it, we will definitely let the Economic Development Services Dept. know.
