Subject: 2021 Splash Pad Lifecycle Projects

Recommendation

It is recommended that:

1. The 2021 splash pad lifecycle projects valued at \$47,000 be approved and funded through the Splash Pad Lifeamp Reserve.

Background

The Municipality maintains 9 splash pads in the Communities of Bothwell, Chatham, Dresden, Mitchell's Bay, Ridgetown, Tilbury, Thamesville, Wallaceburg and Wheatley.

The Splash Pad Lifeamp Reserve was established with funding from the following areas:

- One-time allotment of utility funds for the Tilbury splash pad not utilized in 2011 in the amount \$15,000
- An annual splash pad lifeamp allotment implemented in 2015 in the amount of \$8,500 and increased to \$28,500 in 2017
- In 2016, a transfer of pool reserves remaining after the closure of Memorial Pool in Chatham in the amount \$55,800
- An allotment of \$8,500 was approved during 2018 budget deliberations for the lifeamp funding of the new Wallaceburg splash pad

This reserve will be used to fund repair and replacement costs of various splash pad components.

Comments

Administration has identified the following as priority projects to be completed in 2021. A contingency has been added for quote overages and emergency repairs or replacements.

The estimates of each individual project have been removed to ensure a competitive bid process.
