7. Education/Training

a) COVID-19 and Vaccines update, by Dr. David Colby, Medical Officer of Health

In an effort to update the Board, Dr. Colby shared a PowerPoint presentation, highlighting the following points:

- As of September 14, Chatham-Kent had 116 active COVID-19 cases, 16 people in hospital, and 17 deaths (unchanged since June Board meeting)
- Virtually all hospitalized cases are unvaccinated individuals
- As of this meeting, there are two outbreaks in Chatham-Kent
- Almost all new cases are the Delta variant and are contacts of known cases
- Two cases of the Mu variant have been detected
- As of this meeting, Chatham-Kent has administered over 142,000 doses of vaccine
- 73% of those age12 and up have two doses of vaccine, 53% of those between the ages of 12-17 have two doses of vaccine, 88% of those over the age of 80 have two doses of vaccine; working on increasing numbers in the 12-17 age group
- The mass vaccination clinic will be replaced by pop up clinics in the community, as well as pharmacies
- Currently vaccinating about 200 people/day, many are first doses
- Long Term Care and High Risk Retirement Home residents are eligible for their booster vaccine five months after their second dose was administered
- Immunocompromised individuals are eligible for a third dose 8 weeks after their second dose was administered to complete primary series (the third dose is not considered a booster)
- Routine third doses are not considered at present
- Need to stay the course, continue extensive case and contact management, get people isolating when they need to be isolating, and reaffirm the safety and effectiveness of vaccines

Background

The purpose of this report is to provide an overview of current events or issues arising at Public Health.

Comments

Amendments to Ontario Public Health Standards and Protocols

On June 9, 2021 CK Public Health received notice that the Ontario Public Health Standards, Protocols and Guidelines had been amended. In particular, the following documents have been amended:

- OPHS 2021
- Oral Health Protocol, 2021
- Consumption and Treatment Services Compliance and Enforcement Protocol, 2021
- Tobacco, Vapour and Smoke Protocol, 2021
- Tobacco, Vapour and Smoke Guideline, 2021

A majority of the changes are 'housekeeping'. These include:

- A requirement to deliver the Ontario Seniors Dental Care Program (OSDCP) in accordance with the revised Oral Health Protocol;
- Amendments to the Effective Public Health Practice Standard; Chronic Disease Prevention and Well-Being Standard; School Health Standard and Substance Use and Injury Prevention Standard to incorporate the *Tobacco*, Vapour and Smoke Protocol, 2021 and the *Tobacco*, Vapour and Smoke Guideline, 2021; and
- Changes to update or remove historical references that are no longer relevant.

The Consumption and Treatment Services Compliance and Enforcement Protocol, 2021 is new and currently there is no expectation of immediate action by boards of health. The Ministry will communicate at a later date with respect to timing of required enforcement, training on the new protocol, and other next steps.

2021-2022 and 2022-2023 Ministry of Health Funding Approvals

On July 22, 2021 CK Public Health received notice from the ministry that it will receive up to \$7,273,500 in base funding for the period January 1, 2021- December 31, 2021.

CK Public Health will receive up to \$2,402,500 in one-time funding for the period of April 1, 2021- March 31, 2022 which includes the following:

- \$968,000 in mitigation funding
- \$150,000 in COVID-19 extraordinary costs
- \$222,000 in COVID-19 vaccination efforts
- \$562,500 in Ontario Senior Dental Program capital for dental clinic renovations
- \$500,000 for the school-focused nurses initiative

In addition, CK Public Health will receive up to \$165,000 in one-time funding for the period of April 1, 2022- March 31, 2023 for the school-focused nurses initiative.

The story behind Orange Shirt Day:

"I went to the Mission for one year. I had just turned 6 years old. We never had very much money, and there was no welfare, but somehow my granny managed to buy me a new outfit to go to the Mission School in. I remember going to Robinson's store and picking out a shiny orange shirt. It had eyelets and lace, and I felt so pretty in that shirt and excited to be going to school! Of course, when I got to the Mission, they stripped me, and took away my clothes, including the orange shirt. I never saw it again, except on other kids. I didn't understand why they wouldn't give it back to me, it was mine! Since then the colour orange has always reminded me of that and how my feelings didn't matter, how no one cared and how I felt like I was worth nothing. I finally get it, that the feeling of worthlessness and insignificance, ingrained in me from my first day at the mission, affected the way I lived my life for many years...I want my orange shirt back!"
