7. Education/Training

a) COVID-19 and Vaccines update, by Dr. David Colby, Medical Officer of Health

In an effort to update the Board, Dr. Colby shared the following report:

- Overview of current local, provincial, national, and international case rates
- New cases in Ontario down 3% in the past week, active cases down 7%, deaths increased 30%, hospitalizations increased 5%, and ICU occupancy down 8%
- The indicator that experiences the most lag is deaths; it's concerning to see them go up in the last week along with hospitalizations
- As of this meeting, Chatham-Kent has 37 active cases being followed and three people in hospital with COVID-19
- As of this meeting, Chatham-Kent has four outbreaks, one of them in a long-term care home
- So far Chatham-Kent has administered 215,544 doses of vaccine
- Vaccine rates:
 - Ages 5 to 11 years-42 % have received one dose, 24.7% have received two doses
 - Ages 12 to 17 years-70.3% have received two doses, 8% have received a third dose
 - Age 12 years and up-85.4% have received two doses, 53.1% have received three doses
 - Age 80 years and up-88.6% have received three doses

- There is a new sub variant of Omicron, ba.2, that is more transmissible and will supplant original Omicron
- Priority right now is booster doses especially for those over age 50
- Novavax is available in Chatham-Kent
- Medicago plant-derived vaccine has been approved by Health Canada
- Case and contact management continues only for high risk congregate settings
- Mandatory masking ends March 22, except for healthcare facilities and where required under federal law, hopefully will see additional guidelines on this by the end of the week

In response to questions from the Board, Dr. Colby:

- Clarified that gathering limits and masking are no longer in effect for church services
- Cautioned that indoor gatherings are the kind of scenario where we can see explosive spread
- Indicated that there is a company pursuing a combination vaccine for both influenza and COVID-19, in the meantime the two vaccines are licensed to be administered together but you would receive two separate needles
- Reminded the Board of the value of proper handwashing

RE: Ontario Regulation 116/20, Work Deployment Measures for Boards of Health

Dear Dr. Moore,

On behalf of the Association of Ontario Public Health Business Administrators (AOPHBA), I am writing to you concerning the Ontario Regulation 116/20, Work Deployment Measures for Boards of Health.

This Regulation, in place since April 2020, has proven invaluable in ensuring that public health units (PHUs) are able to effectively respond to the COVID-19 pandemic. Since April 2020, public health work has evolved and changed rapidly in response to both local and provincial directions and demands in areas such as case and contact management, outbreak management in our most vulnerable settings, the development and implementation of the vaccination program, and the continued support and leadership provided to community partners including businesses, municipalities, schools, health related agencies, etc.

It is the opinion of the Association Executive that public health units' continued response to the COVID-19 pandemic will be significantly negatively impacted if PHUs do not have the flexibility necessary to deploy staff how and where needed. PHUs have one or more unions within their employ and many of our members have noted that the restrictions of the various collective agreements often do not allow redeployment of PHU staff to different roles or different areas within the PHU, nor assignment of work on weekends, evenings, and holidays, all of which have been critical to vaccine clinics. The flexibility that this Ontario Regulation provides is critical to our ability to continue to plan and execute both local and provincial directives in line with our mandate, for the balance of 2022.

We respectively ask that you consider extending Ontario Regulation 116/20 Work Deployment Measures for Boards of Health for the duration of public health units' response to the COVID-19 pandemic.
