Included in the Honorarium Related Benefit for Councillors is a 6.60% pooled benefit charge covering the cost of Canada Pension (CPP) and Employer Health Tax (EHT). In regard to the remuneration for the Mayoral position, the pooled benefit charge is 23.40%.

Office equipment includes cell phones, fax machines and other telecommunication expenses. Travel, Training and Car Allowance is separated into Local and International. Local expenses relate to expenses incurred within the province and International expenses were incurred on Economic Development trade missions.

Total Council remuneration and expenses were \$754,683 (budget \$797,411).

The Municipality is also required to report on any remuneration and expenses paid to or for officials appointed to local boards and agencies by Council. Appendix A is a list of 2020 appointees and their related payments.
