Subject: County of Kent Crest Corn Mural

### **Recommendation**

It is recommended that:

1. The County of Kent Crest corn mural currently on display at the Public Utilities Commission office located in the McGeorge building in Chatham, be offered to an interested party in the Chatham-Kent community through a closed bid process.

### **Background**

The County of Kent Crest corn mural is displayed in the office area of the McGeorge Building. The mural was commissioned by Pioneer Hi-Bred Limited and was donated to the County of Kent on October 31, 1984. The artist was Bill Green of Stable Studios in Charing Cross. Attached (Appendix A) is a picture of the mural. In 2015, staff within the Clerk's Office were contacted by a volunteer of the Chatham-Kent Agriculture Hall of Fame committee regarding the possibility of the mural being moved to the John D. Bradley Centre. At this time it is unclear why the relocation of the corn mural to John D. Bradley Centre did not occur.

### **Comments**

In 2015, The Curator, Chatham-Kent Museum confirmed that the corn mural in question is not the property of the Museum. It was not accessioned into the museum's collection, nor has it ever been treated as a museum artifact.

In June, 2021, the General Manager, Public Utilities Commission contacted the Municipal Clerk's office to inquire about the removal of the corn mural in question due to upcoming renovations at the McGeorge building. Subsequently, the Municipal Clerk

reached out to the Arts and Culture division of Community Human Services, for advice on the disposition of the corn mural.

The Acting Curator of the CK Museum advised that, at the present time and for the foreseeable future, the Museum is not accepting artifacts due to COVID concerns, space, handling and storage limitations.

The Curator, Chatham-Kent Thames Art Gallery, confirmed that the piece is not part of the gallery collection and recommended that the original donor be contacted to determine if they would like the corn mural returned to them. Contact was made with Corteva's (formally Pioneer Hi-Bred Ltd.) Government and Industry Affairs Leader, Canada, by the General Manager, CHS. Corteva does not have the capacity to take ownership of the corn mural and supports the piece being offered to a local interested party.

Parties interested in assuming responsibility for the corn mural in question are encouraged to submit their interest in writing to the Municipal Clerk's office by September 15, 2021. If there are multiple submissions, the award will be by lottery. The individual or organization wishing to take ownership of the corn mural will be responsible for costs associated with its relocation.
